1. Ongoing calls for feedback and calls for evidence by the EU Commission

The Net-Zero Industry Act is open for feedback until the **27**th of June **2023**.

The <u>European Critical Raw Material Act is open for feedback</u> until the **27th of June 2023**.

2. Corporate Sustainability Due Diligence Directive (CSDDD) - Update

On the 25th of April 2023, it was announced that the Legal Affairs Committee (the lead committee on the CSDDD dossier) adopted their position on the CSDDD with 19 votes for, 3 votes against and 3 abstentions according to the press release by the European Parliament.

Next steps:

- There will be a plenary on the 1st of June 2023 in which the CSDDD will be discussed.
- According to the press release, "once the Parliament adopts its mandate in the plenary, the negotiations with the Council on the final text of the legislation can start."
